OFFICE MEMORANDUM

Subject: Cancellation of offer of appointment for the post of Assistant Communication Officer (ACO) post code No. NW11720 in DCPW, MHA.

The undersigned is directed to refer this Directorate's OM of Even No. dated 13.03.2023, 23.03.2023, 13.04.2023 and 16.05.2023 vide which offer of appointment for the post of Assistant Communication Officer (ACO) in DCPW, MHA, were issued. The candidates were requested vide above said OMs to inform/report to this Directorate within 60 days from the date of issue of above said OMs. And the time period allowed to join the post should in no case exceed three months.

2. Further, in this regard, the candidates were given another opportunity vide this Directorate's OM of even no. dated 11.09.2023 to report (in person) to the Assistant Director (Admin.), DCPW HQrs, New Delhi within 07 days from issuance of this said OM dated 11.09.2023 [same was published on DCPW website as well]. It was also communicated vide above mentioned OM that "failing to do so within the due date, unwillingness for joining the post of ACO in this Directorate will be assumed from your end and offer of appointment issued will be considered as cancelled."
