
### कार्यालय ज्ञापन / OFFICE MEMORANDUM

**Subject: Strict Adherence to Rules of Conduct regarding political influence in service matters - regarding.**

The undersigned is directed to refer to MHA's I.D. Note No. 25018/09/2025-PM-II dated 12.05.2026 on the subject cited above and to convey that recently it has been observed that some of the employees of DCPW are bringing political or outside influence to bear on superior authorities regarding service matters specifically relating to transfer, postings. Such practices are in direct violation of Rule 20 of Central Civil Services (Conduct) Rules, 1964 which stipulated as under:

**"Canvassing of non-official or other outside influence:** No Government servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of matters pertaining to his service matters under the Government."

2. All officers/officials of this Directorate are, therefore, advised to refrain from adopting such practices and may seek redressal of their service-related grievances, if any, through the prescribed official channels only.
3. Any instance of violation of the above instructions shall be viewed seriously and the officers/officials responsible for such violation shall be liable for strict disciplinary action under the relevant rules.

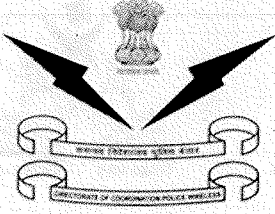

### कार्यालय ज्ञापन / OFFICE MEMORANDUM

**विषय: सेवा संबंधी मामलों में राजनीतिक प्रभाव के संबंध में आचरण नियमों के कड़ाई से अनुपालन के संबंध में।**

उपरोक्त विषय पर अधोहस्ताक्षरी द्वारा गृह मंत्रालय के पत्र संख्या 25018/09/2025-PM-II दिनांक 12.05.2026 के संदर्भ में यह संज्ञान में लाया जाता है कि हाल ही में यह देखा गया है कि डीसीपीडब्ल्यू के कुछ कर्मचारी स्थानांतरण एवं पदस्थापन जैसे सेवा संबंधी मामलों में अपने हितों को आगे बढ़ाने के लिए राजनीतिक या बाहरी प्रभाव का उपयोग कर रहे हैं। यह आचरण केंद्रीय सिविल सेवा (आचरण) नियम, 1964 के नियम 20 का उल्लंघन है, जिसमें निम्न प्रावधान है:

**“गैर-सरकारी अथवा अन्य बाहरी प्रभाव का उपयोग:** कोई भी सरकारी कर्मचारी सरकार के अधीन अपनी सेवा से संबंधित मामलों में अपने हितों को साधने के लिए किसी भी उच्च अधिकारी पर किसी भी प्रकार का राजनीतिक या अन्य बाहरी प्रभाव डालने का प्रयास नहीं करेगा।”

2. अतः निदेशालय के सभी अधिकारियों एवं कर्मचारियों को सलाह दी जाती है कि वे ऐसी गतिविधियों से दूर रहें तथा यदि कोई सेवा संबंधी शिकायत हो तो उसे केवल उचित सरकारी माध्यमों से ही प्रस्तुत करें।
3. उपरोक्त निर्देशों के उल्लंघन का कोई भी मामला गंभीरता से लिया जाएगा तथा ऐसे उल्लंघन के लिए उत्तरदायी अधिकारी/कर्मचारी के विरुद्ध संबंधित नियमों के अंतर्गत कड़ी अनुशासनात्मक कार्रवाई की जाएगी।

## CENTRAL CIVIL SERVICES (CONDUCT) RULES, 1964

### 19. Vindication of acts and character of Government servant

(1) No Government servant shall, except with the previous sanction of the Government, have recourse to any Court or to the Press for the vindication of any official act which has been the subject-matter of adverse criticism or an attack of a defamatory character.

<sup>34</sup>Provided that if no such sanction is received by the Government servant within a period of three months from the date of receipt of his request by the Government, he shall be free to assume that the permission as sought for has been granted to him.

(2) Nothing in this rule shall be deemed to prohibit a Government servant from vindicating his private character or any act done by him in his private capacity and where any action for vindicating his private character or any act done by him in private capacity is taken, the Government servant shall submit a report to the prescribed authority regarding such action.

### 20. Canvassing of non-official or other outside influence

No Government servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of matters pertaining to his service under the Government.

### <sup>5</sup>21. <sup>12</sup>Restriction regarding marriage-

(1) No Government servant shall enter into, or contract, a marriage with a person having a spouse living; and

(2) No Government servant, having a spouse living, shall enter into, or contract, a marriage with any person:

Provided that the Central Government may permit a Government servant to enter into, or contract, any such marriage as is referred to in clause (1) or clause (2), if it is satisfied that-

- (a) such marriage is permissible under the personal law applicable to such Government servant and the other party to the marriage; and
- (b) there are other grounds for so doing.

<sup>12</sup>(3) A Government servant who has married or marries a person other than of India Nationality shall forthwith intimate the fact to the Government.

### 22. Consumption of intoxicating drinks and drugs

A Government servant shall -

- (a) strictly abide by any law relating to intoxicating drinks or drugs in force in any area in which he may happen to be for the time being;
- (b) not be under influence of any intoxicating drink or drug during the course of his duty and shall also take due care that the performance of his duties at any time is not affected in any way by the influence of such drink or drug;
