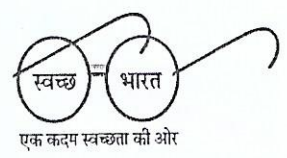

OFFICE MEMORANDUM

Subject: Recruitment in the grade of 'Multi Tasking Staff, Group 'C' Non-Gazetted, in Directorate of Coordination Police Wireless through Multi Tasking (Non-Technical) Staff and Havaldar (CBIC & CBN) Examination, 2022 conducted by SSC - reg.


