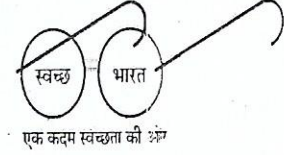


Subject: Cancellation of candidature to the post of Assistant Communication Officer (Cipher), Post Code NR-15121 in DCPW, MHA.


