The detailed guidelines of the same may be perused on the exclusive Portal/website for Awards i.e. www.nca-wcd.nic.in. It may be mentioned nere that only online application forms submitted by applicants will be entertained. Forms submitted through any other mode will not be considered for the Awards.
- These Awards are given by the Hon'ble President of India in Darbar Hall, Rashtrapati 8havan on week preceding Republic Day every year. Hon'ble Prime Minister of India also felicitates the Awardees. The Awardees of Bal Shakti Puraskar also take part in Republic Day Parade on the 26th of January in Rajpath. New Oethi
