^{*} Penalty was imposed on Shri Jai Prakash, CO, ISPW Bhopal for withholding increment of pay under Rule 11(iv) of CCS (CCA) Rules, 1965 for a period of two years vide DCPW Order No. A-13020/5/2022-Ad.I dated 12.08.2022 w.e.f. from 12.08.2022 by the Director, DCPW, being the Disciplinary Authority in r/o Group 'B' officials of the Directorate. The penalty was completed on 11.08.2024, and a dies-non of 21 days (from 27.02.2012 to 03.03.2012), therefore official became eligible for grant of 3rd MACP on 02.09.2024.

2. The financial up-gradation under the MACPS is purely on personal basis in the immediate higher Pay Level and shall not amount to actual/functional promotion of the employees concerned. No stepping up of pay in the pay band would be admissible with regard to junior getting more pay than the senior on account of pay fixation under MACP Scheme. The seniority of the above officials in the respective grade will remain unchanged.



- 3. The pay and date of increment would be fixed in accordance with the clarification No.2 of the Department of Expenditure's O.M. No.1/1/2008-IC dated 13.09.2008. The above mentioned employees may exercise their option under FR 22(I)(a)(1) to get their pay fixed on financial upgradation under MACP Scheme, within one month of issue of this order.
- 4. The financial up-gradation is subject to audit verification and recovery if any, at any stage.
- 5. This issues with the approval of the Competent Authority.
