

OFFICE MEMORANDUM

Subject: Recruitment in the grade of 'Multi-Tasking Staff, Group 'C' Non-Gazetted, in Directorate of Coordination Police Wireless through Multi-Tasking (Non-Technical) Staff and Havaldar (CBIC &CBN) Examination, 2022 conducted by SSC - reg.

Reference may be made to the recommendations of Staff Selection Commission vide which the names of 54 candidates for appointment to the post of 'Multi-Tasking Staff' in DCPW, MHA was conveyed to this Directorate.

- 2. The recommended candidates [46 Nos.] were requested vide this Directorate's OM of even No. dated 26.02.2024 to submit their duly filled SSQs/ Attestation Forms (AFs) and Medical Examination certificate to this Directorate in order to complete the pre-appointment formalities regarding appointment to the post of 'Multi Tasking Staff' in DCPW, MHA.
- 3. In this regard, following 04 Nos. of candidates remained un-responsive and have not forwarded the required forms as stipulated above till date even after providing three opportunities vide OM dated 26.02.2024 and subsequent reminders dated 02.09.2024 & 05.11.2024:-

Further, following 05 candidates who have been offered appointment to the post of MTS in DCPW, MHA have not reported to their respective place of posting even after completion of 03 months as stipulated in offer of appointments. Furthermore, vide this Directorate's OM dated 05.11.2024, the Competent Authority has provided one more opportunity to 05 nos. of candidates to report (in person) within 02 weeks from

issuance of this OM, clearly mentioning therein that failing to do so within the due date, unwillingness for joining the post of MTS in this Directorate will be assumed from their end and offer of appointment issued will be considered as cancelled.
